All students, from all backgrounds, receive value for money.

# The aims of the OfS fair access and participation review

The aim of the fair access and participation review is to:

1. achieve a **significant reduction in the gaps in access, success and progression over the next five years**, shifting from incremental to transformational change.
2. regulate and fund access and participation in a way that is consistent with the wider OfS regulatory approach, so that it is outcome-based, risk-based, underpinned by evidence and joined up with other regulatory activities.

# The fair access and participation review

## Office for Students principles:

- Institutional autonomy
- Student focused and working in the interest of past, present and future students
- Risk-based and proportionate, including the reduction of unnecessary regulatory burden
- Outcomes focused
- Making judgments based on data and contextual evidence

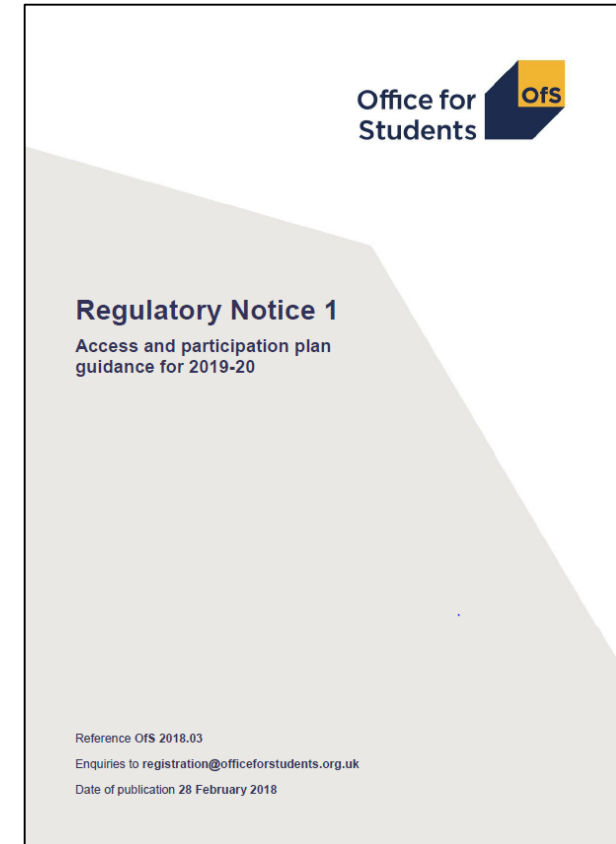

# Access and participation plans

- Access and participation plans set out how higher education providers will improve equality of opportunity for underrepresented groups to access, succeed in and progress from higher education.
- They include:
  - the provider's ambition for change, the measures it will put in place to achieve that change
  - the targets it has set
  - the investment it will make to deliver the plan.
- If providers want to charge higher tuition fees, their plans must be approved by the Director for Fair Access and Participation.

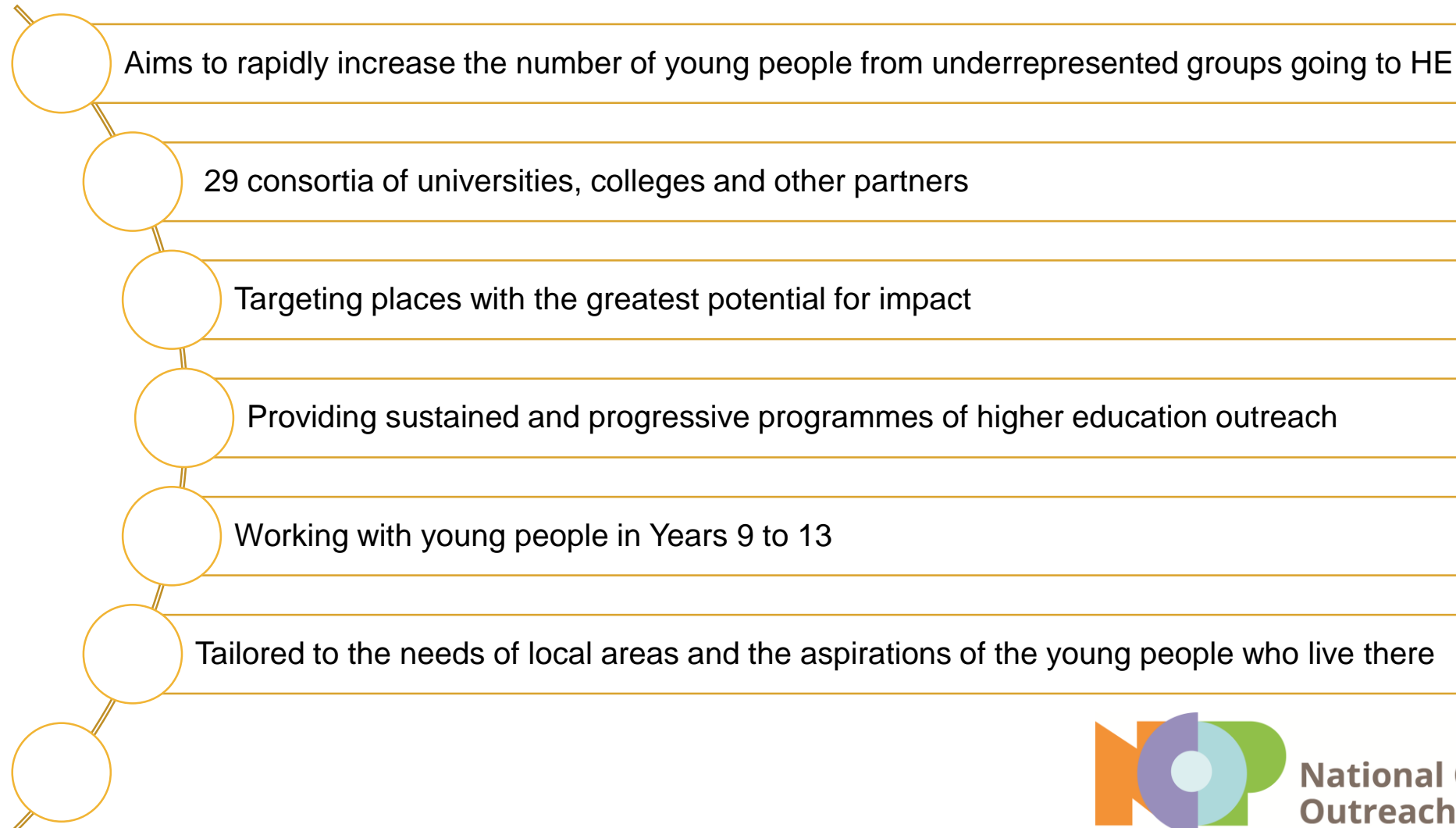

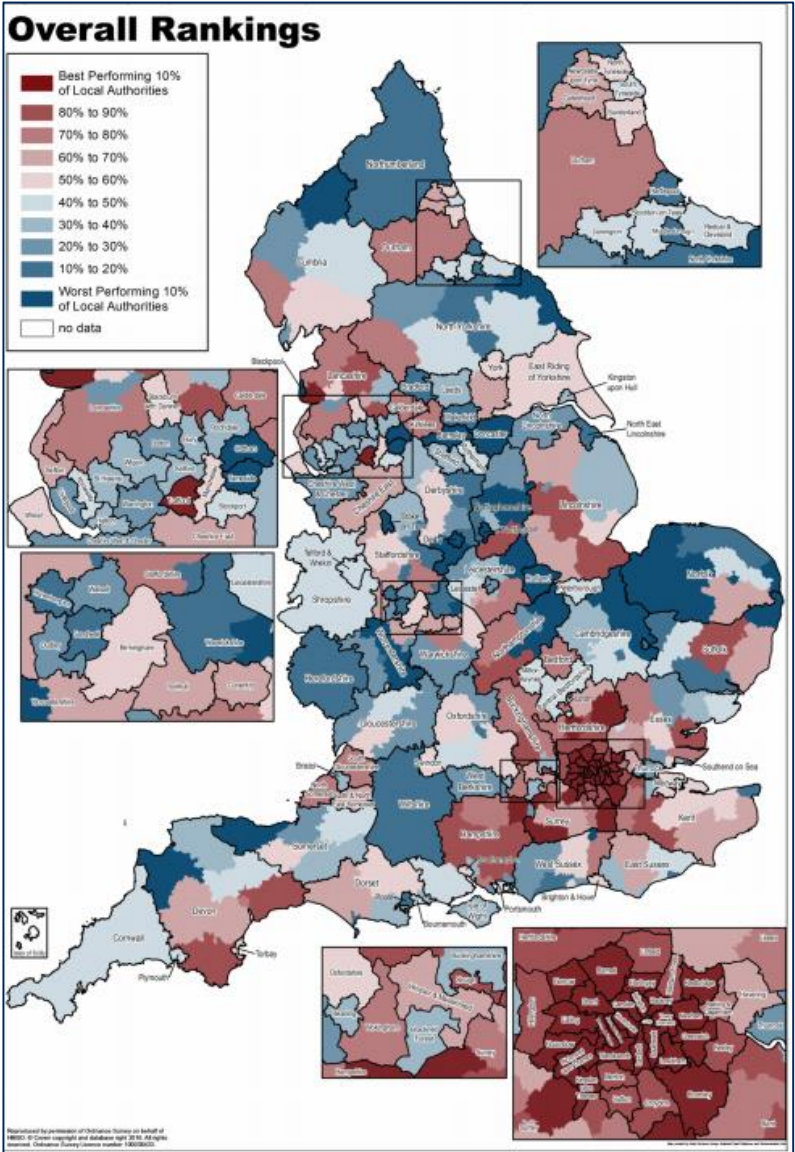

# Why is collaboration important in securing transformational change?

“Collaboration between providers and other stakeholders (such as schools, colleges and the third sector) is crucial for sustained engagement with schools and for students to receive high quality, impartial advice and guidance relating to higher education. Collaboration also helps to increase coverage and avoid duplication...”

“...This is particularly important in relation to the effort to improve access to higher education, because this begins from early years, and pupils and students need objective advice on the options available to them at each stage”
